## Policy Requirements – High to Medium Risk Vendors

Includes: Alarm Systems, Carpentry, Concrete, Curtain Wall Repair, Demolition, Electrical, Elevators, General Contractors, HVAC, Locksmiths, Mechanical, Movers, Plumbing, Roofing, Security Guards, Fire Sprinklers, Trash Hauling, and Window Washing

General Liability Limits: \$1,000,000 each occurrence

\$2,000,000 in the aggregate

Coverage: Insurance will be occurrence form, will name Owner and

Manager as additional insureds, will contain a waiver of subrogation against Owner and Manager, will be primary coverage (not excess), will include but not be limited to Contractor's operations, blanket contractual, personal injury, completed operations and contractual liability for

indemnification set out in the contract.

General: Aggregate limit applies per location.

Forms: Copy of specific additional insured endorsement must be

attached and noted on Certificate of Insurance.

Includes: Painting, Flooring, Millwork, Pest Control, Landscaping, Snow Removal, Janitorial/Cleaning, Blinds, and Interior Plant Maintenance

General Liability Limits: \$1,000,000 each occurrence

\$1,000,000 in the aggregate

Coverage: Insurance will be occurrence form and will name Owner

and Manager as additional insureds, will contain a waiver of subrogation against Owner and Manager, and will be primary coverage (not excess). Coverage will include but not be limited to Contractor's operations, blanket contractual, personal injury, completed operations and contractual liability for indemnification set

out in the contract.

General: Aggregate limit applies per location.

Forms: Copy of specific additional insured endorsement must be

attached and noted on the Certificate of Insurance.
